ANNOUNCEMENT TO CANDIDATES

1. For the candidates **who have qualified in the written examinations and fulfill the experience criteria**, mark sheets will be sent **along with provisional certificate** by post **within two weeks**.
2. For the candidates **who have not qualified**, mark sheets will be dispatched by post **within a week**.
3. The supplementary candidates who have qualified in all the papers but fall short of experience **should send the experience certificates as and when they acquire the requisite number of years of work experience for the issue of Provisional Certificate**. However, **Mark sheets will be sent to them within a week by post**.
4. If a candidate is not satisfied with the marks awarded in any paper(s) and feels that there is possibility of either omission in marking of any answer(s) or there is possibility of mistake in totaling of the marks in any paper(s), the candidate may seek **verification of marks in one or more paper(s) by submitting an application** accompanied by a fee of **Rs. 200/- per paper**, to be paid by **DD** drawn in favour of **“Bureau of Energy Efficiency” payable at “Chennai”** so as to reach the Controller of Examination **within a month of the declaration of the results**.
